The Declaration

I am confident my husband and I are born again Christians and we, along with certain other loved ones named herein, will be caught up while living in the Rapture together and will have no reason for any earthly possessions ever again; however, if for some reason unknown to any of us, I, or of my loved ones believed to be saved souls should be left behind at the time of the Rapture, this Rapture Will is null and void, and the provisions of my Last Will and Testament with its named beneficiaries will supersede this Rapture Will.

In the event that any of my beneficiaries named in this Rapture Will should accept Christ as their savior prior to this prophesized event and be among the living raptured with us, the remaining beneficiaries will equally divide my estate. Should each of my named beneficiaries be raptured, my alternate named beneficiaries shall inherit my entire estate. Should my alternate named beneficiaries accept Christ prior to the Rapture and they, too, are raptured, then my executor(s) will sell my estate and establish a trust fund to benefit: 1) shelters and care centers for special needs individuals who become displaced following the Rapture; and 2) animal shelters in my community to care for the many pets left behind when their human families vanish. ARTICLE I IDENTIFICATION OF FAMILY

This is a painful and moving decision, because I believe these precious souls to be unsaved souls. I base that belief on their lack of profession of faith, their lack of a Christian's walk and a spoken and demonstrated relationship with the Lord, our Savior, the absence of the fruits of the spirit that exist in born again Christians and upon my observations of their worldly pursuits and lifestyles. Although one among these three family members professes salvation through Christ, her current life choices defy that commitment and show her to be out of communion with God. While I realize that only she and God know the true destiny of her soul, I am compelled to include her among my beneficiaries at the writing of this Rapture Will to ensure that she, too, will have a way to help meet her needs during the difficult and treacherous times that will come for those left behind.

While I and other saved family members have on numerous occasions shared the gospel with our loved ones living without soul insurance through Christ, I am compelled to include my beloved nephews (insert full legal names and locations), and my only niece, (insert full legal name and location of this individual) as my Rapture Will beneficiaries.

ARTICLE IV PET CARE DIRECTIVES

Notwithstanding any other provision of this Rapture Will, I further direct that:

A. <u>Pet Caretaker.</u> I give my pet, (Insert Pet's Name)

- A. <u>Power to Administer Estate.</u> My Independent Executor, with respect to my estate, in addition to other powers and authority granted by law or necessary or appropriate for proper administration, shall have the following rights, powers, and authority without order of court and without notice to anyone: to identify, gather, value, secure, manage and distribute assets, to maintain records, to settle and wind up business affairs, to pay just debts, to file necessary tax returns, to redirect mail, to cancel services, to establish trusts, and to carry out my wishes as set forth in this Rapture Will.
- B. <u>Independent Administration.</u> My Independent Executor shall have the right to administer my estate using "informal", "unsupervised", or "independent" probate or equivalent legislation designed to operate without unnecessary intervention by the probate court, with the following exception of circumstances listed in section C of Article VI:
- C. <u>Supervised Administration</u>. In the event that all my named beneficiaries and alternates should come to know our Lord and Savior through salvation prior to the prophesized Rapture event, our should predecease the Rapture event, my Independent Executor will proceed with the distribution of my estate under the direction of the family court system of my locale at the time of my living Rapture.

ARTICLE VII MISCELLANEOUS PROVISIONS

A. <u>Paragraph Titles and Gender.</u> The titles given to the paragraphs of this Rapture Will are inserted for reference purposes only and are not to be considered as forming a part of this Will in interpreting its provisions. All words used in this Rapture Will in any gender shall extend to and include all genders, and any singular words shall include the plural expression, and vice versa, specifically including "child" and "children", when the context or facts so require, and any pronouns shall be taken to refer to the person or persons intended regardless of gender or number.

- B. <u>30-Day Survival Requirement.</u> For the purposes of determining the appropriate distributions under this Rapture Will, no person shall be deemed to have survived me unless such person is also surviving on the 30th Day after the hour of my living Rapture.
- C. <u>Compensation</u>. The Executor is entitled to receive reasonable compensation for his or her services under this Rapture Will and be exonerated from and to pay all reasonable expenses and charges of the estate and trust.
- D. <u>Beneficiary Disputes</u>. If any bequest requires that the bequest be distributed between or among two or more beneficiaries, the specific items of property comprising the respective shares shall be determined by such beneficiaries if they can agree, and if not, by my Independent Executor.
